## **Corps of Engineers lists “Operation Blue Roof” locations for Nov. 4**

JACKSONVILLE, FLA. – The U.S. Army Corps of Engineers, Jacksonville District, announces Right of Entry forms will be available on November 3<sup>rd</sup> at the locations listed below. Locations are open in 13 south Florida counties.

The Operation Blue Roof program provides a temporary remedy for roof damage sustained during Hurricane Wilma. A homeowner must first sign the right of entry form before workers can assess the amount and type of roof damage and whether installation of blue plastic will constitute an appropriate temporary repair. Only primary residences that have sloped, shingled roofs are eligible to receive a blue roof. Roofs with greater than 50% structural damage, metal, tile and flat roofs are not eligible.

Right of entry collection centers are open daily from 8 a.m. to 5 p.m. unless indicated otherwise.
