

Consistent with the intent stated in this Review Plan the District should ensure that a more detailed dam break analysis is performed during design phase activities and that subsequent revisions to this Review Plan are made which covers design phase activities and accounts for the resulting hazard classification, including appropriate Type II IEPR efforts.
