C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

 - Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR).
 - Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction. Explain: **The 0.49 acre wetland present in the review area is a wet depression located adjacent to Hunt Brothers Road. The on-site isolated wet depression appears to have been a natural depression area dating back to 1941. The site elevation undulates somewhat, and this subject depression area is the lowest point in the landscape (see attached topography map) and does not demonstrate any surface hydrologic connections to other wetlands or waters. The subject depression appears to be fed by rainwater and used as a location for absorption and attenuation. This system was once connected to offsite waterways, but this connection was severed when Hunt Brothers Road was constructed in the late 1960s. The nearest waterway is an artificial canal located more than 4,000 feet to the west of the property boundary. The wetland is an isolated depression found on a xeric oak sandhill. No ditches or drainage features are associated with, or connected to this wet depression. Permanent standing water occurs in the most southern portion of the wet depression. The wetland appears to only stage water after storm events, and then percolates through sandy soils. The wetland likely provides full life history support for a very limited assemblage of insects and small amphibians, but due to the physical isolation and habitat barriers it does not support significant immigration or emigration of such species to or from other regional wetlands or waters. The wetland may provide limited life-history support for larger amphibians and reptiles as breeding or foraging habitat, ephemeral foraging habitat to wading birds and small mammals, and temporary escape or bedding habitat for mammals; however, given its location in the landscape, limited hydrologic regime and small size, these functions are insignificant when considered relative to the larger wetland complexes in its vicinity. This wetland has features that are physically, chemically, and hydrologically isolated from other regional wetlands and there is no clear significant nexus by which jurisdiction can be claimed.**
