Hogtown Creek is the dominate perennial stream feature within the Hogtown Creek subwatershed. Hogtown Creek originates from artesian springs in northeastern Gainesville and terminates at Haile Sink located in**

southwestern Gainesville. Waters discharged into Haile Sink directly recharge the Floridan aquifer. Water discharged into Haile Sink eventually travels northeast to the Santa Fe River. However, groundwater travelling from Haile Sink to the Santa Fe River likely takes many years. No dye tracer studies have been conducted at Haile Sink. The closest TNW is the Santa Fe River, located approximately 21 miles northeast of the subject wetlands and surface waters. Additionally, the subject wetlands and surface waters do not provide a substantial nexus to interstate commerce.

Wetlands L, M, N, O, P, Q, R, S, T, U, V, W, X, Y, Z and AA are located within the River Rise-Santa Fe River watershed (0311020605). The subject wetlands are located primarily within San Felasco Hammock Preserve State Park. None of the subject wetlands abut or are adjacent to Blues, Turkey or Cellon Creeks. Blues, Turkey and Cellon Creeks are perennial streams that drain to sinkholes within San Felasco Hammock Preserve State Park. Waters draining to sinkholes recharge the Floridan aquifer. It is unknown if waters recharging the Floridan aquifer in San Felasco Hammock Preserve State Park travel to the Santa Fe River via groundwater flow. No dye tracer studies have been conducted in San Felasco Hammock Preserve State Park. The closest TNW is the Santa Fe River, located approximately 12 miles northeast of the subject wetlands. Additionally, the subject wetlands do not provide a substantial nexus to interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

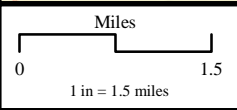
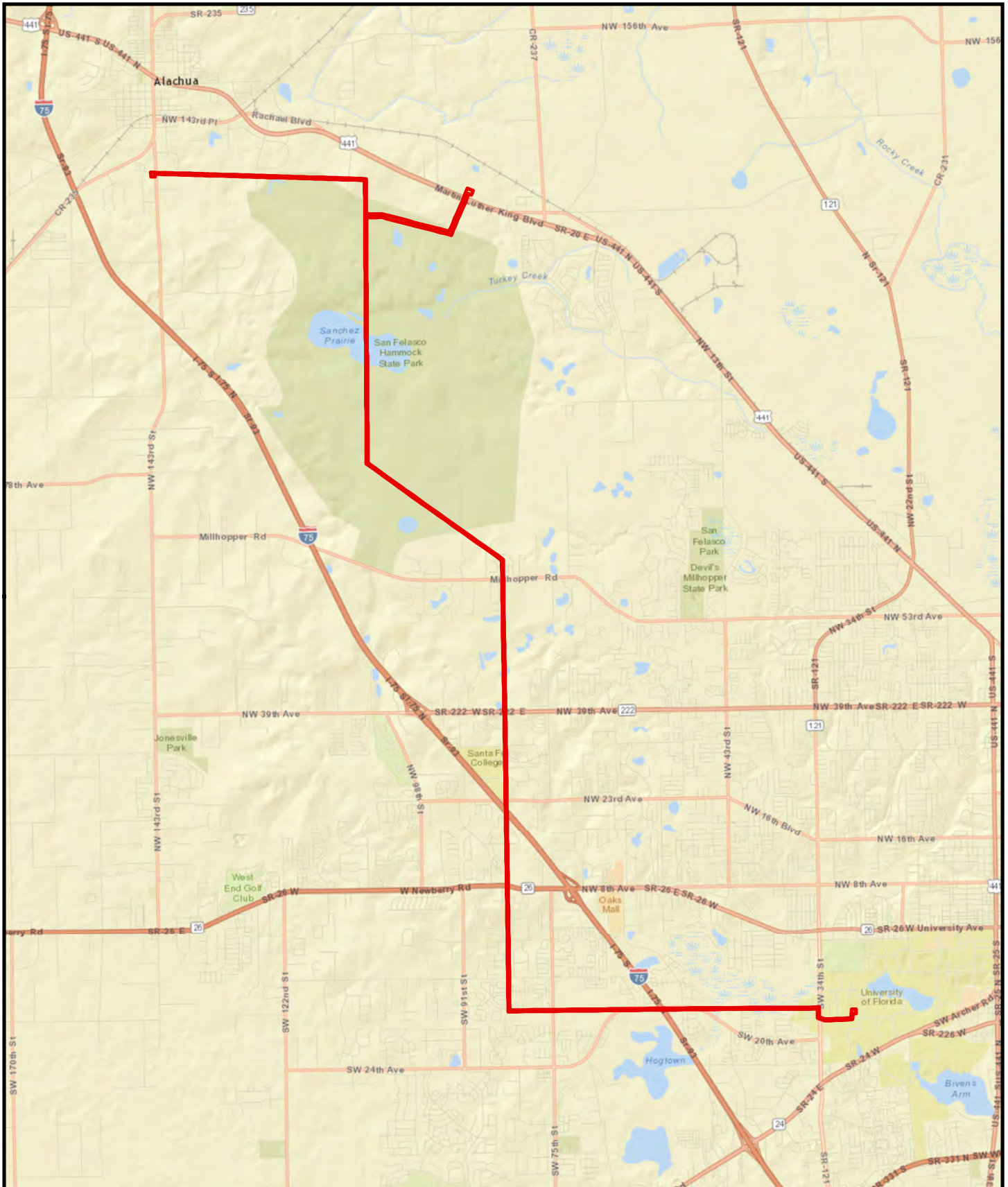

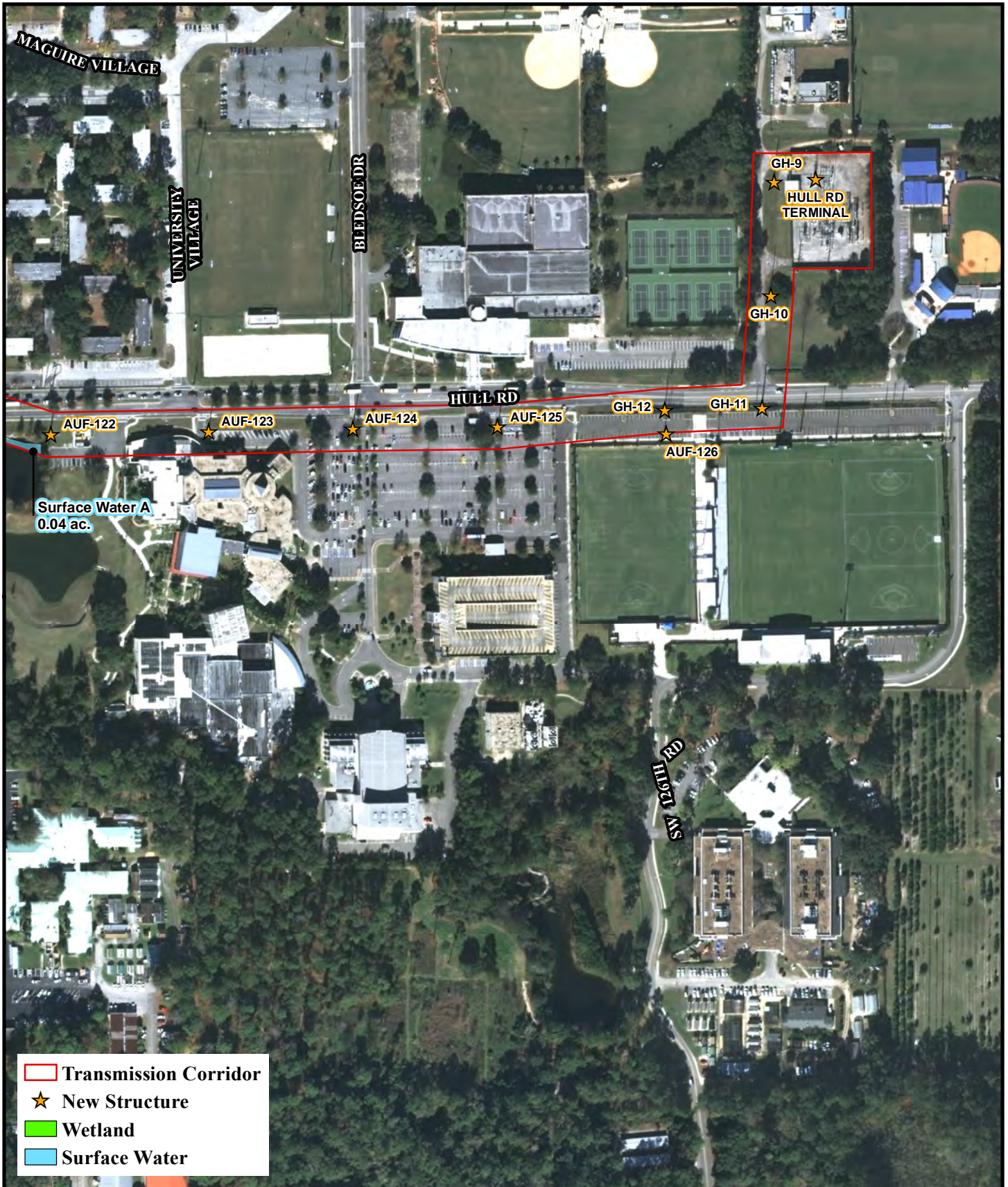

Transmission Corridor

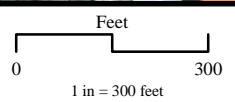

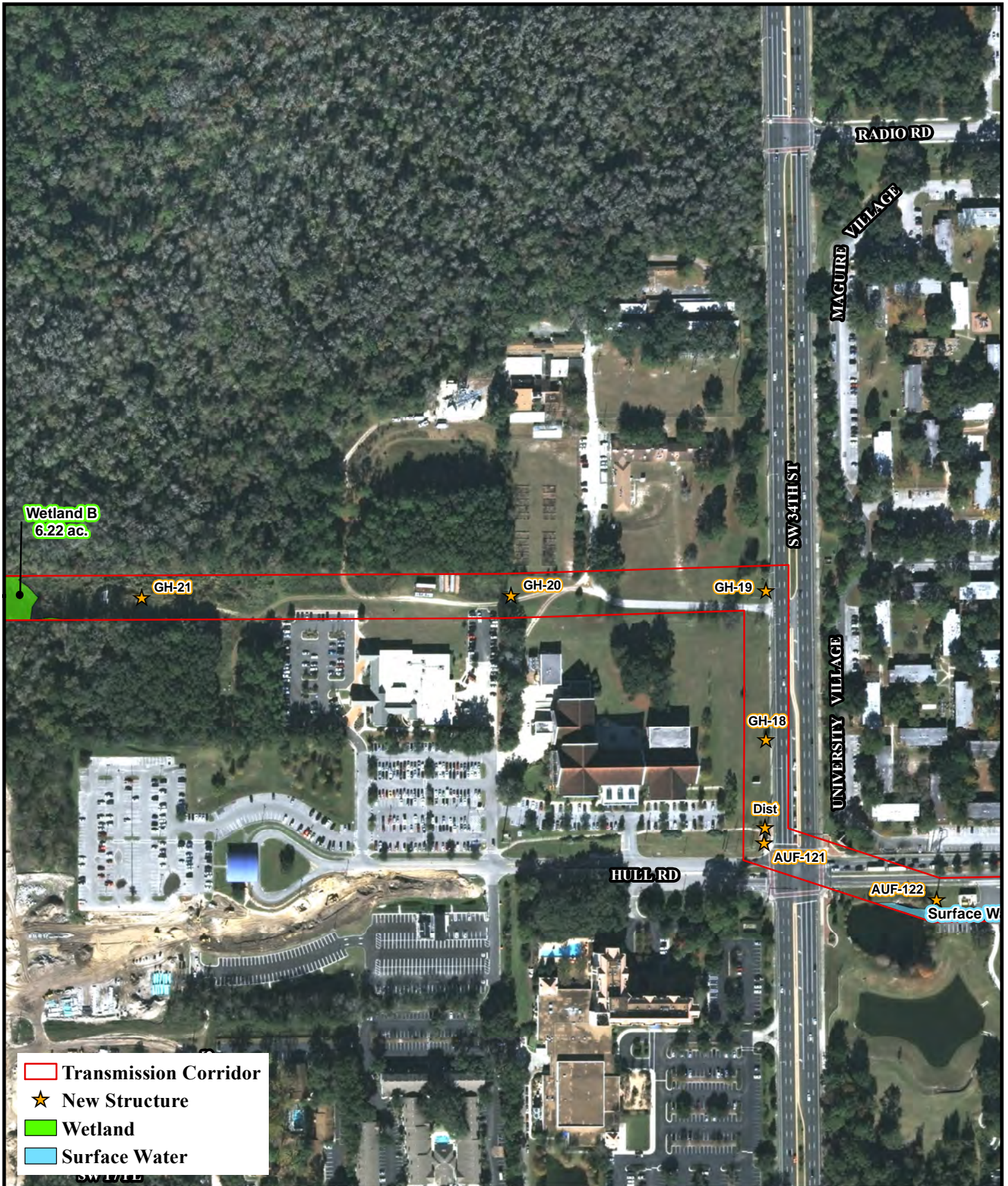
