### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

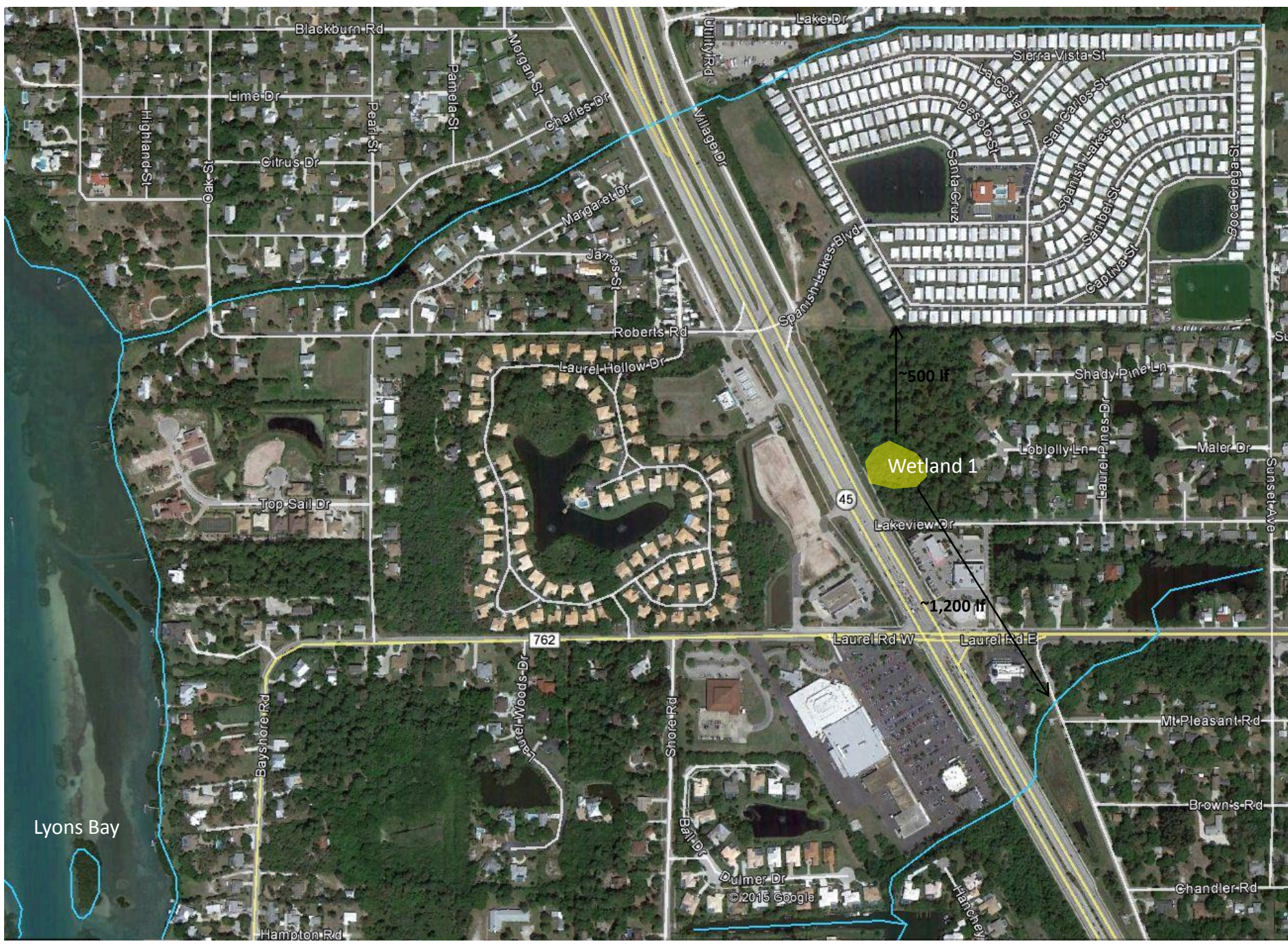

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A desk review of the site was completed using recent aerial imagery, the NWI, NHD Flow lines, the USGS Topo Quad, and other remotely sensed data available on the SAJ Resources at Risk Database to determine the presence and proximity of other surface waters. The subject wetland is approximately 1,200 linear feet from an unnamed tributary to Lyons Bay and approximately 500 linear feet from a ditch that connects to a downstream TNW. The wetland is situated in a depressional area surrounded by

forested and developed uplands. The wetland also appears isolated in aerial imagery from 1948 (UF Digital Collections). The Corps has determined the onsite wetland is isolated as it does not connect hydrologically to downstream waters nor does it have a significant nexus to downstream waters .
