### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

limestone in 1981 and 1982," of the 37.4 million tons of phosphate rock produced in the U.S., Florida remained the predominate producer and for the 89<sup>th</sup> consecutive year, supplied more than any other State. Florida and North Carolina supplied 84.8% of the domestic phosphate rock output and Florida supplied most of the exports" (The Mineral Industry of Florida, MOA between the Bureau of Mines, US Department of Interior, and the Florida Bureau of Geology, by James Boyle and Charles Hendry, Jr, 1882). While the mine was in operation, "Florida continued to be the Nation's leading phosphate rock mining State in 1999, producing more than six times as much as the next highest-producing State. Phosphate rock is produced in only four States... According to Florida Geological Survey, Florida producers supplied approximately 25% of the world's phosphate needs and 75% of U.S. domestic needs... Florida continued to be third in crushed stone production... Florida ranks 15<sup>th</sup> in the Nation in construction sand and gravel used or produced and 20<sup>th</sup> in industrial sand." (The Mineral Industry in Florida, MOU between the US Geological Survey and the Florida Geological Survey, 1999). With the extensive amount of material extracted from Florida mines and the ability to supply the Nation with limestone, sand, gravel and stone, the Corps has determined that Bishops mine is used for industrial purposes and sold in interstate commerce.

**Identify water body and summarize rationale supporting determination:** Once the mining in the lake is completed, it will consist of 231 acres. Prior to mining operations, the site was used for pasture and sod farm. Historically, the site was Everglades sawgrass marsh wetlands with hydric soils (Dania muck). The South Florida Water Management District issued permit 50-01556-S for stormwater management on 9 April 1987, and FDEP issued a permit to construct the mining lake. The mining lake contains a depth of -33 feet NGVD. The mine is currently extracting sand and gravel and once completed, residential development would be constructed around the perimeter of the mining pit.

The mining lake acts as a closed system. Excess stormwater from the upland site either enters into the North Springs Improvement District master stormwater system on the site before being discharged either into the mining lake or into the Hillsboro Canal (L-36 Canal), which is a TNW.
