C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

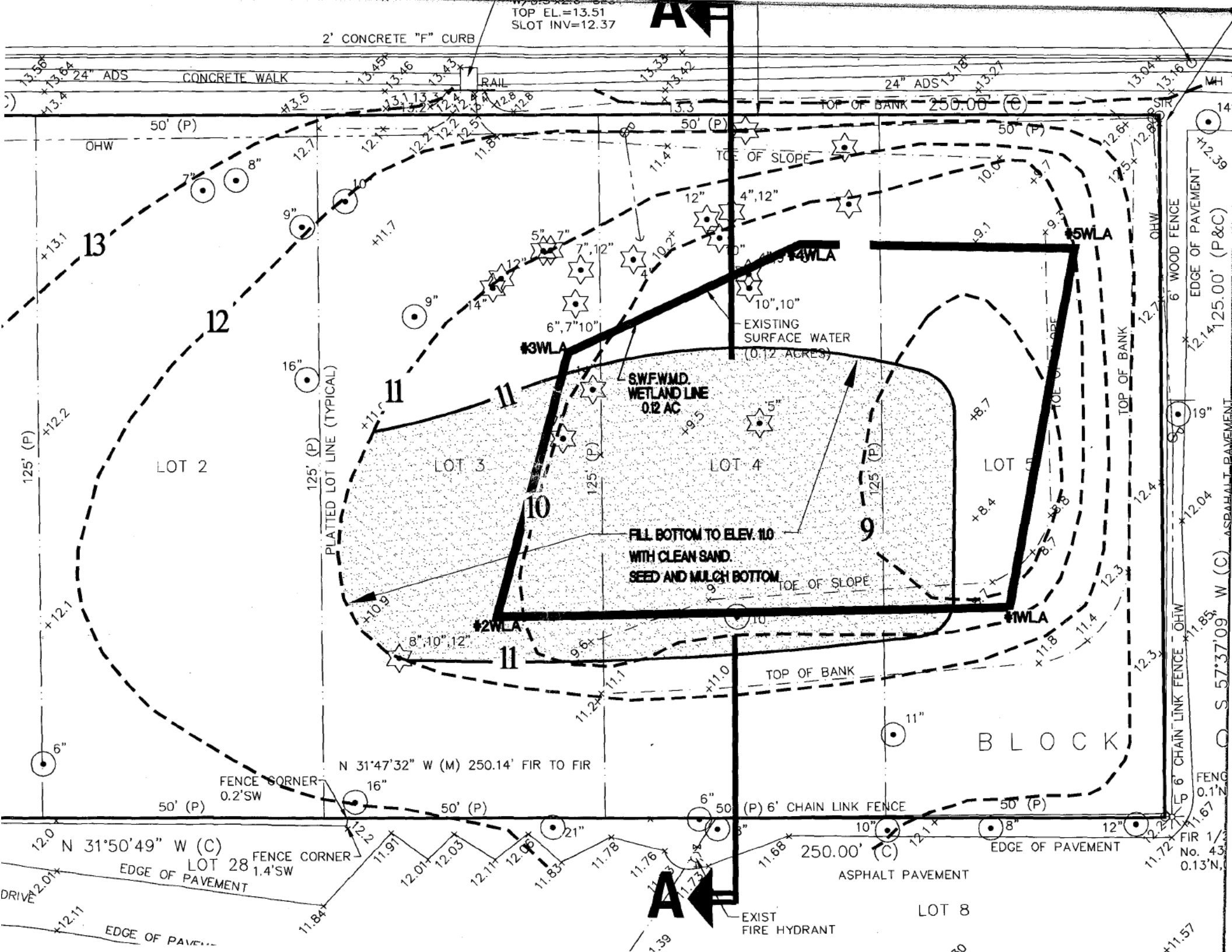
The wetland within the review area is a 0.12 acre wet depression dominated by cattail (*Typha* sp.) immediately adjacent to U.S. 19. The property owner stated that he believed the wetland may have been created by excavation for fill material a number of years ago. This is a possibility, since the Corps reviewed a number of historic aerial images which do not depict a definite wetland signature. Additionally, the

uneven, somewhat bermed slopes of the wetland edge may be a result of excavation. The wetland is immediately surrounded by uplands and roadways to the north, a building and paved parking lots to the south, U.S. 19 to the east and uplands and paved parking lots to the west. The wetland appears to be an isolated depression with no surface connection or unbroken shallow subsurface connection to jurisdictional waters. There is a ditch located 150 feet to the south of the review area which receives runoff from U.S. 19. There is a stormwater inlet/slot which opens to the review area and leads to a stormbox under the sidewalk on US 19. The slot has an invert elevation of 12.37 ft and is 25 to 30 ft landward of the wetland edge. The wetland edge on the east side is approximately 10 ft in elevation. The slope is much steeper on the east side leading to the inlet/sidewalk. The west side has a broader slope. There was evidence in the field that water had pooled on the west side, but no evidence that water had or would ever reach the storm junction box. The storm junction box would need to fill up, travel down a pipe under the sidewalk to another junction box, fill up, and then discharge to the ditch. As this is extremely unlikely to happen, the wetland is effectively isolated from waters of the U.S.
