### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This document determines the jurisdictional status of any waters located within the 8.39 +/- acre project site. There are no waters of the U.S. or wetlands located on this site. The entire site is uplands. The Corps conducted a site visit on the property, 26 Feb 2016. Two data points were confirmed during the site visit, one at the north and one in the central area of the property. Hydrologic indicators are no longer present even though the site did contain hydric soils and some hydric vegetation. Overall,

the site was populated with a majority of FAC, FACU, and Upland vegetation. Several soil pit were dug to 16" below the soil surface and no saturated soils, water table or surface water was observed. None of the data points met all three parameters to make the site jurisdictional. The hydrology from the site has been divereted due to the new inffrastructure of the surrounding area. This 8.39 +/- acre site is completely uplands and is not subject to Section 404 Clean Water Act.
