### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Other: (explain, if not covered above): **The subject surface waters include irrigation and drainage ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water to a TNW. The 27,500 linear feet x 30 feet wide irrigation/drainage surface waters (ditches with intermittent flow) are separated from Sottile Canal by water management structures; Sottile Canal drains east approximately 11 miles to the St. Sebastian River and then into the Indian River Lagoon (TNW). The ditches were created to support a citrus operation and are used to irrigate crops during the dry season. Conversely, they drain the agricultural site during the wet season. The network of ditches are can range from flooded to intermittently wet. The surface waters are connected to a drainage canal running north/south along Babcock Street by a control structure. The surface waters intermittently discharge to this canal which flows to the Sottile Canal. The surface waters within the review area do not drain any wetlands areas pursuant to Section 404 of the Clean Water Act and would not be considered a tributary.**

**The surface water adjacent to Babcock Street is not within the review area or subject of this jurisdictional determination and will be evaluated via a separate jurisdictional determination as needed.**

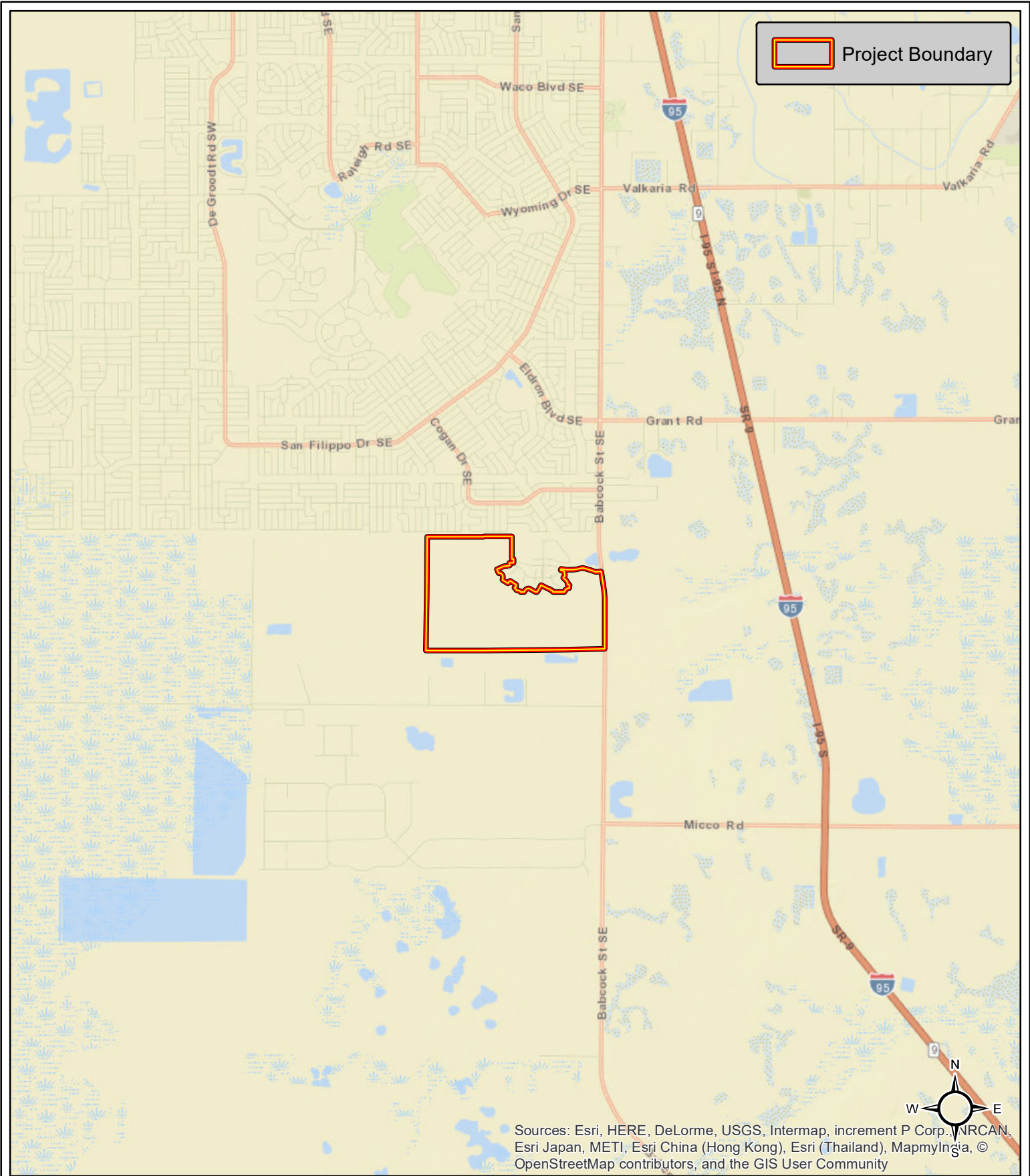

**Figure 1: Location Map**

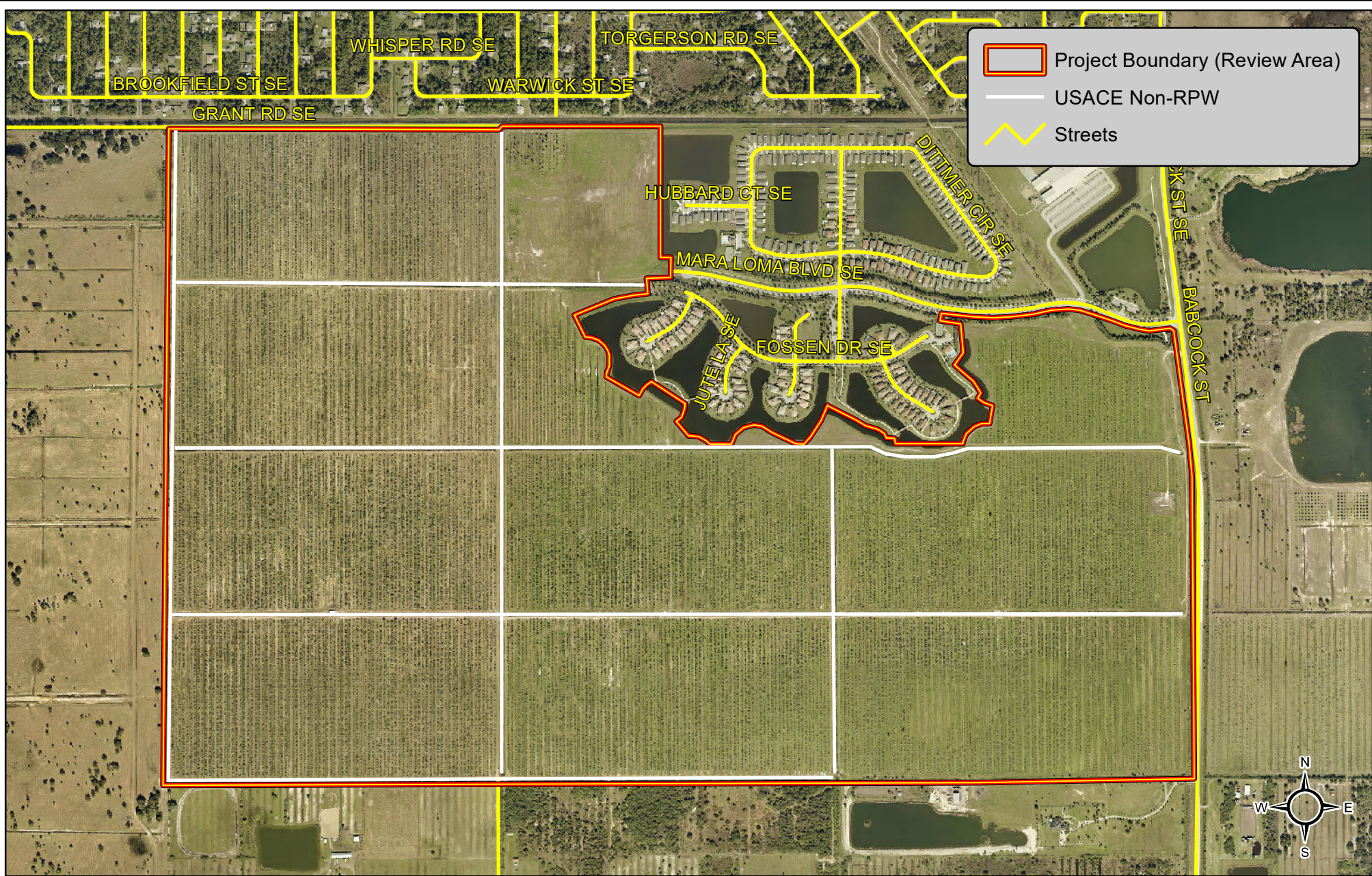
