submitted by the applicant, Palm Beach County. The Corps did not agree with the data sheets submitted by the applicant as there were several issues. The applicant did not claim that there was hydrophytic vegetation, however the data sheets showed that the area passed the dominance test for hydrophytic vegetation. The applicant also did not complete a documented soil profile. Therefore the Corps completed their own wetland data sheet set. Upon inspection of the proposed project site, Corps staff noted that the proposed walkway north of Dyer Boulevard is located on an existing perimeter levee/ trail that is elevated several feet from the surrounding surface waters and other habitats. South of Dyer Boulevard, the walkway was only about one foot elevated from adjacent habitats. The Corps observed possible wetland areas (due to the presence of hydrophytic vegetation) located on the east side of berm's toe of slope, adjacent to the Haverhill Road swale for the length of the remaining project area. Therefore a delineation point was taken within this questionable area adjacent to hydrophytic vegetation. The habitat did not appear to change significantly for the length of the project area. Conclusions: The data point taken did not qualify for a wetland, because it only contained hydrophytic vegetation and did not have soils that passed the hydric soil criteria or hydrology to support a wetland. Please see the data sheet and photos for additional information. Therefore since the data point did not qualify as a wetland, then it was determined that are not wetlands within the proposed project footprint for the walkway.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
