## MEMORANDUM FOR COMMANDER JACKSONVILLE DISTRICT

SUBJECT: Approval of the Review Plan for the G-3273 Constraint Relaxation/S-356 and S-357 Field Test, Modified Water Deliveries to Everglades Nation Park Project

- 2. The Review Plan (RP) for the G-3273 Constraint Relaxation/S-356 and S-357 Field Test, Modified Water Deliveries to Everglades Nation Park Project submitted by the Jacksonville District via reference 1.a has been reviewed by this office. The enclosed RP is hereby approved in accordance with reference 1.b above.
- 3. South Atlantic Division (SAD) concurs with the conclusion of the Jacksonville District that the G-3273 Constraint Relaxation/S-356 and S-357 Field Test is an "other work product" as defined in reference 1.b and that neither an Agency Technical Review nor a Type I Independent External Peer (IEPR) is required on this Field Test. We also concur with the District Chief of Engineering that a Type II IEPR is not required. The primary basis for the concurrence that a Type II IEPR is not required is the determination that failure or loss of this Field Test operating criteria would not pose a significant threat to human life.
- 4. The District should take steps to post the approved RP to its web site and provide a link to CESAD-RBT. Before posting to the web site, the names of Corps/Army employees should be removed. Subsequent significant changes, such as scope changes or level of review, to this RP, should they become necessary, will require new written approval from this office.

SUBJECT: Approval of Review Plan – G-3273 Constraint Relaxation/S-356 and S-357N Field Test, Modified Water Deliveries to Everglades National Park Project

- 1. Reference EC 1165-2-214, Civil Works Review, 15 December 2012.
- 2. The proposed G-3273 Constraint Relaxation/S-356 and S-375N Field Test (Field Test) will contain water management operating criteria, some of which will require a temporary deviation to portions of the 2012 Water Conservation Areas, Everglades National Park, and ENP-South Dade Conveyance System Water Control Plan, Chapter 7 of the Central and Southern Florida Project Master Water Control Manual Volume 4. The supporting Environmental Assessment (EA) is currently being prepared.
- 3. Request approval of the enclosed Review Plan (Enclosure 1) which includes a District Quality Control (DQC) Review of the Field Test EA. Agency Technical Review (ATR) and Independent External Peer Review (IEPR) of the Field Test EA are not required. These conclusions are based on the EC 1165-2-214 Risk Informed Decision Process as presented in the Review Plan.
- 4. Once approved, the Review Plan will be posted to the CESAJ website. Names of Corps employees will be withheld from the posted version, in accordance with guidance.
