2. The South Atlantic Division has completed its review of the revised Review Plan. The revised Review Plan dated 5 August 2011 is approved. HQUSACE has confirmed that absent project reformulation, the Martin County Final LRR is not subject to Independent External Peer Review (IEPR). Therefore, Type I IEPR is not proposed for this project.

3. The District should take steps to 1) post the SAD-approved Final Revised RP and a copy of this approval memorandum to the SAJ District public website and 2) provide a link to the Water Management and Reallocation Studies Planning Center of Expertise for their use. Before posting to the website, the names of Corps/Army employees should be removed. The IEPR exclusion memorandum (reference 1.b.) is incorporated as a part of the approved Review Plan and should be posted as a part of the approved Review Plan.
