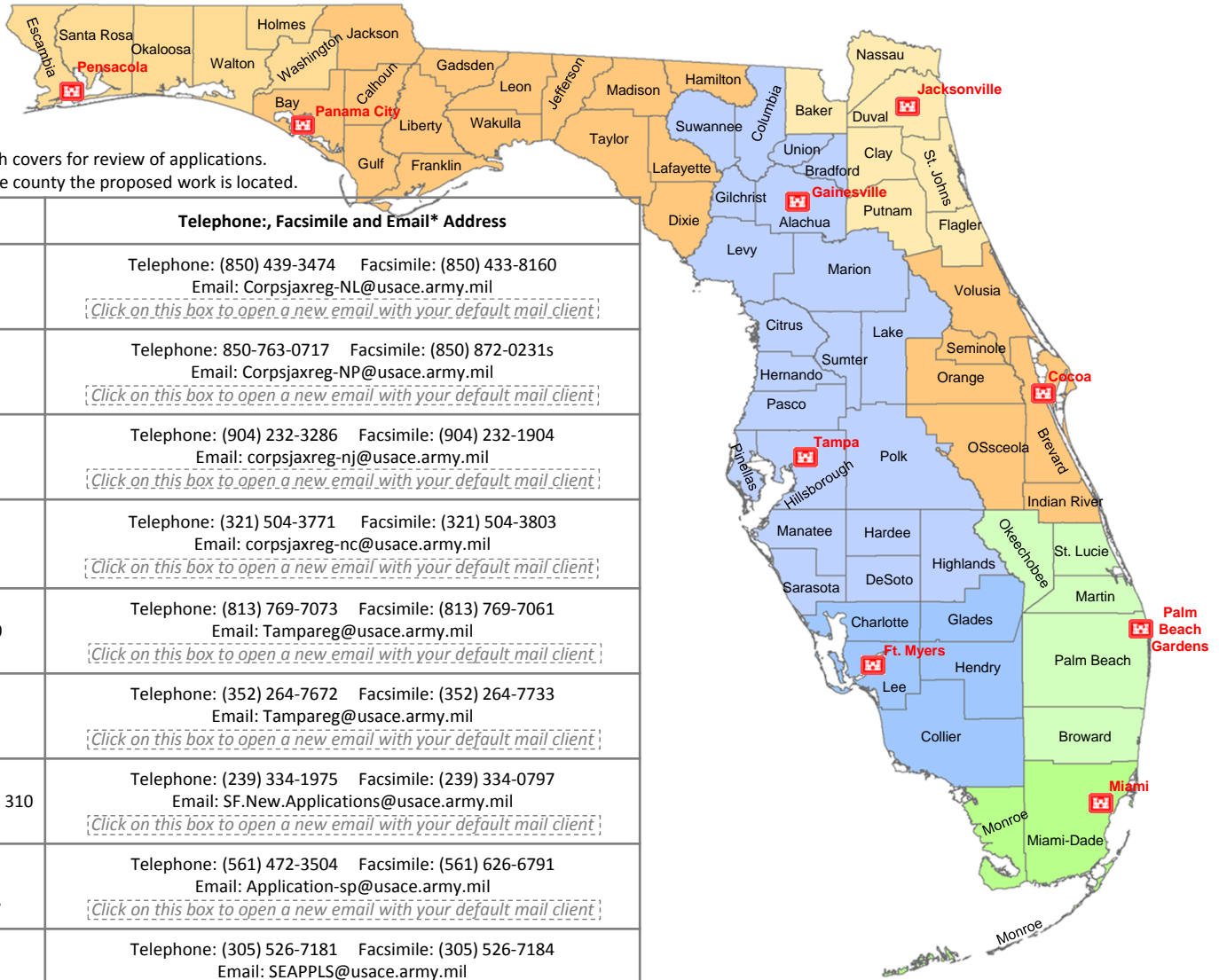


Addresses for Submission of Permit Applications to the Regulatory Division, Jacksonville District, U.S. Army Corps of Engineers
