C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This wetland does not have any direct or indirect connections to waters of the U.S. A review of hydrographic and topographic data show that the wetlands do not have a surface connection to waters of the U.S. A field inspection revealed no surface connections to waters of the U.S. The review area is located within the Lake Wales Ridge. The attached topographic map depicts the wetlands within a 120 foot contour. The ground elevation rises to 125 feet to the east of the review area, then declines around the large wetland system east of Suffolk Place. Non-hydric soils separate the wetlands from potential waters of the U.S. to the east and southeast. Residential development borders the review area to the west; upland agricultural fields border the review area to the south. A subsurface connection between the subject wetlands and waters of the U.S. is not likely. Based on the above information, the wetlands within the review area are isolated and do not significantly affect the chemical, physical or biological integrity of a TNW.
