Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: 49.39 acres of wetlands were determined to be isolated. Wetlands 1, 2, 3a, 3b, 3c, 4a, 4b, 4c, 5, 6, 7, 7a, 7b, 8,9,10,11,12 are non-navigable, intrasate wetlands. They are generally depressional wetlands due to the karst geology of the area and are surrounded by uplands. These wetlands are not connected by any conveyance to any other

wetlands or other waters of the U.S. Any demonstration of shallow-sub-surface flow or ecological interconnection would be to another wetland, not a tribuatry. There is no evident nexus between any of these wetland sand waters and interstate or foreign commerce. These wetlands are directly north of wetlands previously determined by the Corps to be isolated pursuant to an approved jurisdicational determination dated September 8, 2011. Therefore wetlands 1-2, 3a-3c, 4a-4c, 5-6, 7a-7b, and 8-12 are isolated; and pursuant to the Supreme Court decision in the Solid Waste Authority of Northern Cook County vs. U.S. Army Corps of Engineers (SWANCC), these wetlands are not jurisdictional .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
