by means of non-navigable waters or drainage infrastructure, exists. The on-site wetlands are surrounded by uplands as delineated by the criteria of the 1987 Corps Wetland Delineation methodology and Atlantic and Gulf Coastal Plain Regional Supplement. The site is privately owned with no nexus to interstate commerce. The Corps issued an approved jurisdictional determination for this site on 20060927 in which the on-site wetlands were deemed to not be within the Corps' jurisdiction due to being isolated waters. The Corps has determined that the wetlands remained isolated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
