Based on a review of historic aerial imagery, Ponds 3, 4, 6, 7, 8 and 10 were excavated from uplands and do not connect to waters of the U.S. These waters were assessed and determined to be non-jurisdictional based on the preamble to 33 CFR Part 328 in the November 13, 1986, Federal Register (51 FR 41217, Section 328.3). Ponds 2, 5 and 9 were excavated from historic wetland systems and do not**

connect to waters of the U.S. and are considered isolated. These alterations took place prior to 1974 (date of aerial photography). Pond 1 appears to be a historic sinkhole and is not connected to waters of the U.S. and is therefore considered isolated. Wetland 1 is connected to a wetland system south of Jasmine Road and one wetland and one pond east of Little Road via culverts. These systems drain to Wetland 1 and have no hydrologic connection to waters of the U.S.; therefore, Wetland 1 is considered isolated.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.








