**C. PROJECT LOCATION AND BACKGROUND INFORMATION:** The site is located south of Griffin Road and South University Drive intersection, on the west side of South University Drive, east of Madison Lakes Circle E., Section 33, Township 50 South, Range 40 East, Town of Davie, Broward County, Florida.

The project is located within a vacant lot within an urban developed area in Davie, Broward County that was once part of the Everglades. NRCS soil survey says that the area was entirely Plantation Muck, with a Hydric Soil rating of 100%. The site is set to be developed for medical buildings and is surrounded to the North and south by commercial businesses and a multi-family residential development to the west, with a wetland preserve located to the north west of the vacant parcel. A Traditionally navigable water (TNW), the Central and South Florida (C & SF) canal 11 is located approximately 0.43 miles north of the site, located between Griffin Road and Orange Drive, running east to west. The project site does not have any structures or drains, which connect to adjacent stormwater systems, and uplands border the vacant lot on all four sides and therefore there is no connection to the C-11 or other tributaries.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A wetland delineation was prepared in accordance with the 1987 Wetland Delineation Manual and the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Atlantic and Gulf Coastal Plain Region by the consultant and verified by the U.S. Army Corps of Engineers staff (Jerilyn Ashworth and Trey Fraley) on 25 August 2016. The wetland on the project site was approximately 1.11 acres (half of the project site). During the 25 August 2016 site visit, the proposed wetland line approved by the South Florida Water Management District and Broward County was flagged. Corps staff walked the perimeter of the wetland boundary and verified using 1987 Wetland Delineation Manual and the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Atlantic and Gulf Coastal Plain Region that the area was a wetland. Primary hydrologic indicators were observed, which included soil saturation and water stained leaves. The site also contained the secondary indicator of Geomorphic Position since the wetland was depressional from the perimeter upland grade. The site contained hydrophytic vegetation and passed the dominance test. The soil was considered hydric as the soil plug taken was a uniform 17-inch profile of Muck, with a Hue of 10YR and Value/Chroma of 2/1. The texture was muck and using the rub test, no grit was felt after 15 rubs and the sample was greasy. The soil sample passed the hydric soil criteria of Muck Presence, A8. After the field visit, the Corps confirmed with the Applicant that the area was a wetland and the applicant requested an approved jurisdictional determination because they thought the wetland was outside the jurisdiction of the Corps. On 08 September 2016 the Corps conducted a desktop review of the project site to investigate the hydrologic connectivity of the wetland. The Corps found that the wetland not jurisdictional, as it is considered a isolated wetland and is not adjacent to tributaries or Traditional Navigable Waters (C-11 Canal).

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

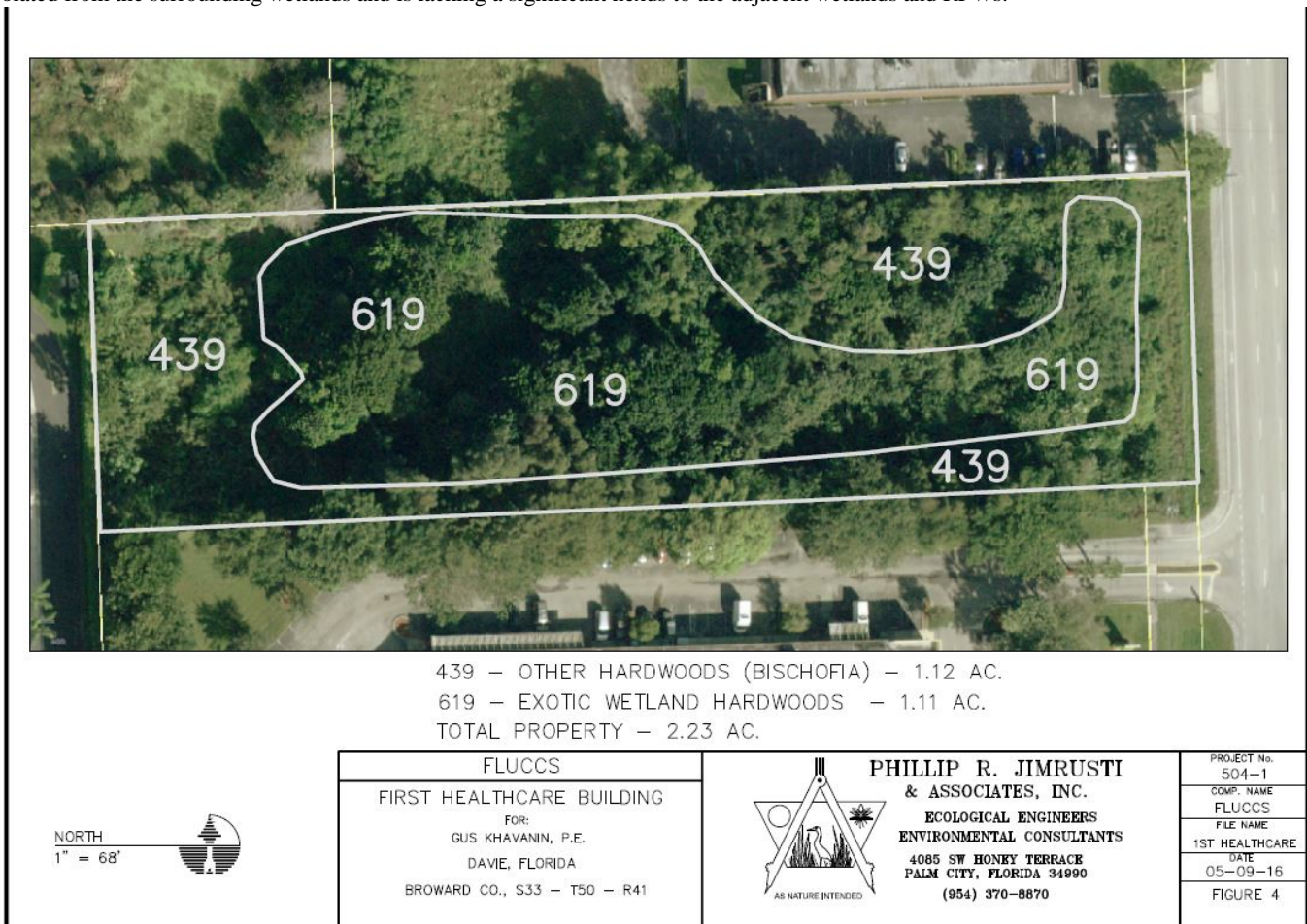

However, Broward County and the South Florida Water Management District had previously been out to the site and the applicant provided those agency reports with their established wetland line. Corps staff requested that that the line be flagged prior the 25 August 2016 site visit. Corps Staff verified the location of the wetland and agreed with the established line set by the SFWMD and Broward County. Corps staff also verified that though there is a wetland on the property, it is not within the Corps' jurisdiction and therefore any proposed buildings/development of the said parcel will receive a No permit required letter..

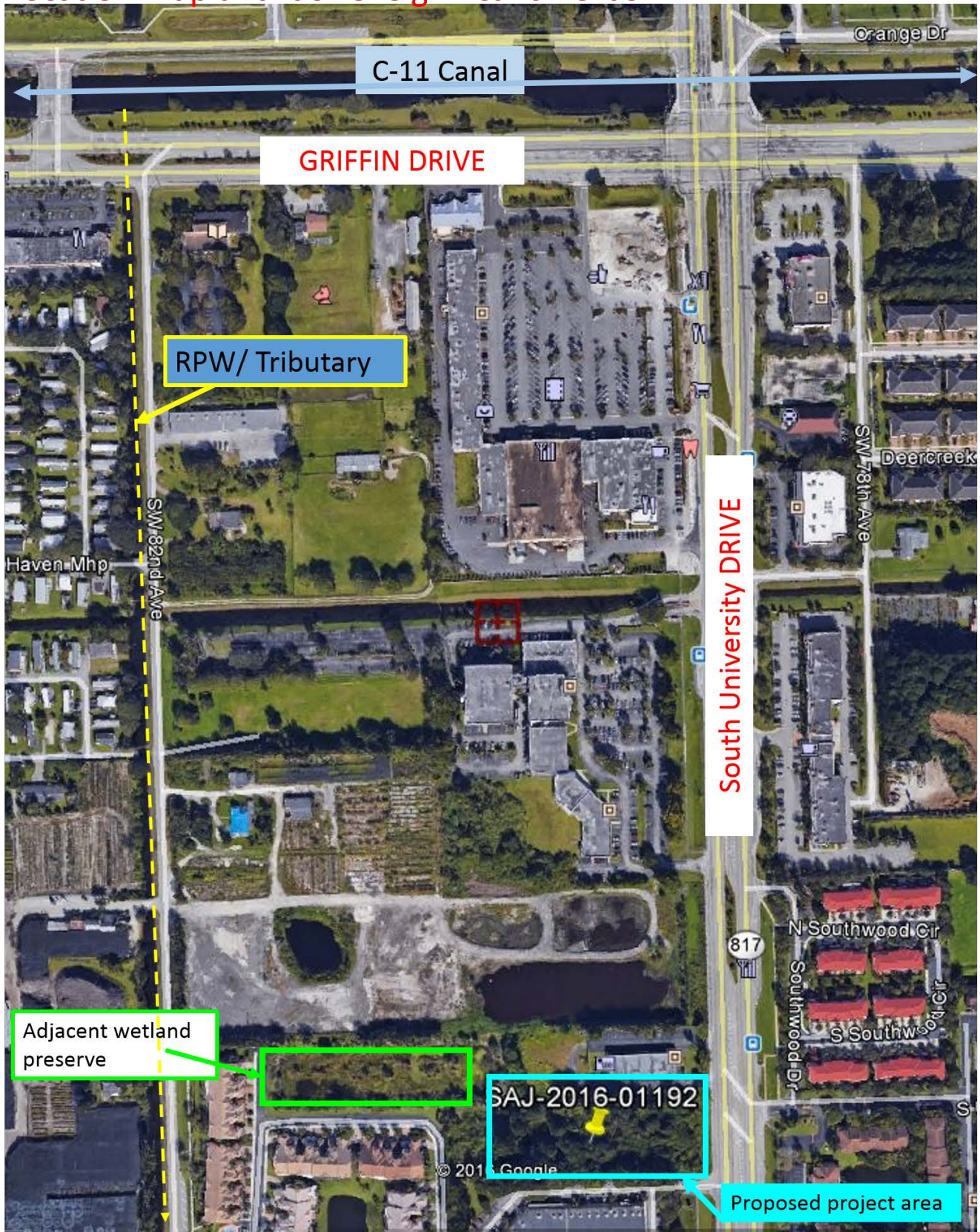


Figure 2. Location map including the location of adjacent wetlands, TNW, and tributary. Figure is oriented, that the top of page is North.

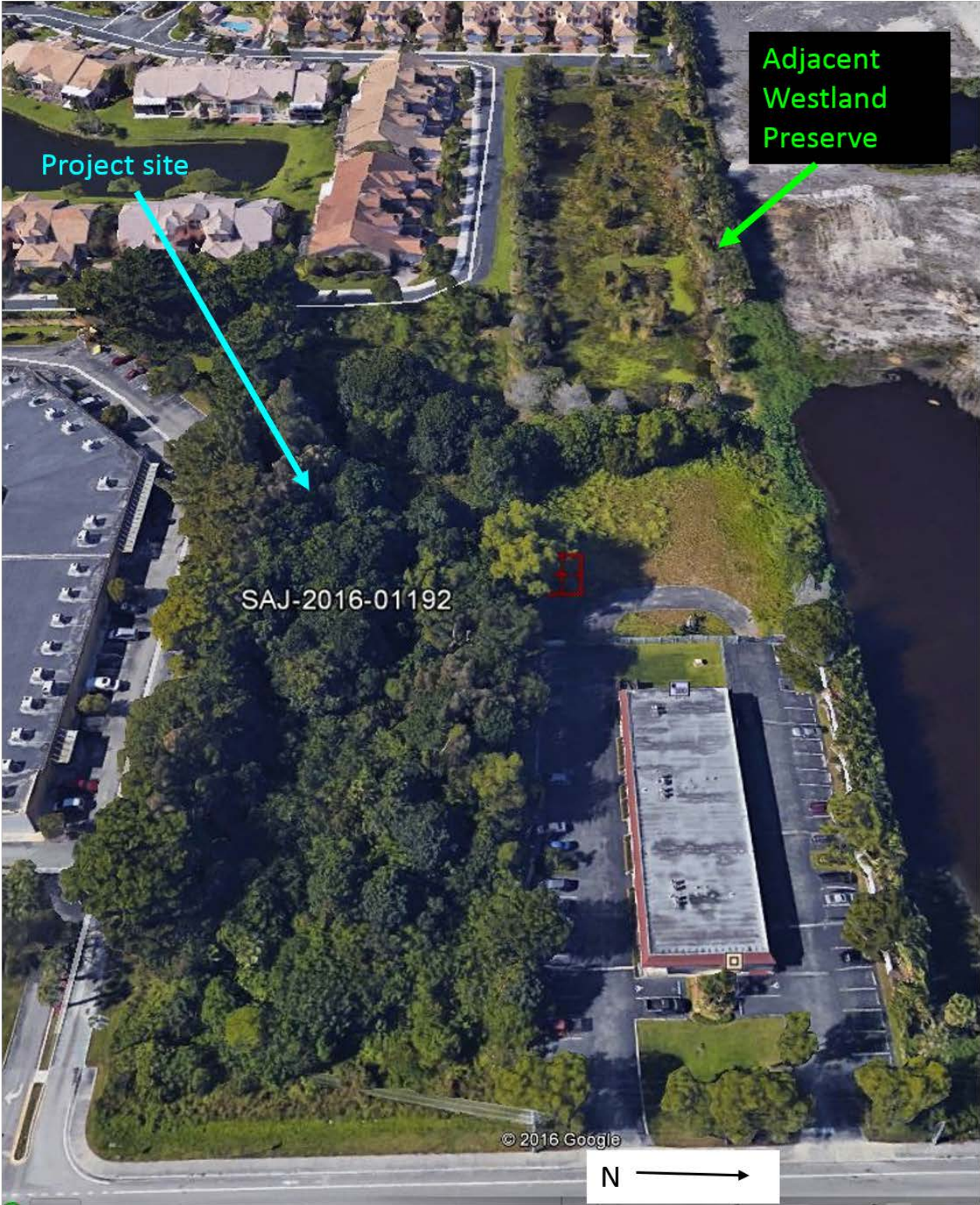


Figure 3. Zoomed in figure of the parcel and adjacent wetland. In the photo you can see the berm elevation and uplands between the two depressional areas.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Figure 1. below shows the location of the verified wetland line and total area of 1.11 acres, labeled by FLUCCS code 619 for exotic Hardwood Wetlands. Figures 2 and 3 show how the parcel and wetland on the property is isolated from the surrounding wetlands and is lacking a significant nexus to the adjacent wetlands and RPWs.
