- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The project area contains 2 isolated wetlands that are centrally located on the subject parcel. One polygon measures 0.19 acres. This polygon can be characterized as a livestock pond that has become a freshwater marsh system (palustrine emergent). The other polygon measures 1.61 ac and can be characterized as a disturbed forested wetland (palustrine forested). These wetland polygons meet all three parameters which define a wetland as defined in**

the 1987 Corps Wetland Delineation Manual and 2010 Atlantic and Gulf Coastal Plain Regional Supplement. The three parameters that were documented for each polygon are as follows:

Hydrophytic vegetation: The dominant vegetation within the forest wetland consisted of earleaf acacia (*Acacia auriculiformis*); paper trees (*Melaleuca quincenervia*), and scattered slash pines (*Pinus elliotti*). The dominant vegetation within the marsh polygon consisted of cat-tails (*Typha* sp.), lily pads (*Nymphaea* sp.), and other emergent vegetation.

Wetland hydrology: The primary hydrological indicator in the forested wetland polygon consisted of thin muck surface. The primary hydrological indicator in the marsh polygon consisted of surface water.

Hydric soil indicators: Hydric soil indicator that was present within the forested polygon is A8 muck presence. The freshwater marsh system was by definition hydric.

These 2 wetland polygons were determined to be isolated since they do not form hydrological connections with the nearby drainage canal to the west or the borrow pond to the south. The forested wetland polygon is located ~800 linear feet to the east of the drainage canal and ~500 linear feet to the north of the borrow pond. This polygon is located within a depression area as documented by the Google Earth elevation profiles. On the west side of the polygon the elevation is ~39 feet and then drops down to ~25 feet within the wetland polygon. The east side of the polygon then goes back up to ~35 feet. The north side of the polygon is ~55 feet with the center of the polygon being at ~25 feet. The south side of the polygon goes back up to ~59 feet. These elevational differences clearly show that this polygon is affected by its geomorphic position in the landscape. The marsh polygon is surrounded by partially paved roads and uplands including habitations. It is located ~670 linear feet to the east of the drainage canal and ~1,100 linear feet to the north of the borrow pond. The Corps conducted a site visit and did not document any hydrological connections between these 2 wetland polygons and the drainage canal to the west and the borrow pond to the south. Given the site conditions described, the aerial photography, and the Corps' site visit, these 1.02 acres of wetlands were determined to be isolated and not regulated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The only jurisdictional wetlands are located on the southeast corner of the site. This wetland polygon measures 0.83 acres and consists of cypress and pine that is highly disturbed with exotic vegetation. This wetland polygon is directly connected to a borrow pond which is then connected by an operable sluice gate structures to the drainage canal on the east side of County Barn Road. The water in that canal flows to the south through several additional canals and ultimately discharges to Naples Bay.
