Explain: The 1.5 acre subject wetland lies on the east site of US Highway 1 approximately 0.19 mile west of the Indian River, a TNW. There are no drainage features which allow a consideration of adjacency to a tributary of the Indian River. The wetland is surrounded by commercial development and undeveloped habitats. The upland habitats are dominated by sandy soils. The sandy soils allows the downward movement of water to the surficial aquifer. This

precludes the opportunity for lateral movement by subsurface flow to the drainage canal ~400 feet east of the wetland. The wetland is separated from the Indian River by residential development and Riversedge Drive. There are no data to support a factual determination of subsurface flow to the nearest drainage canal or the Indian River. No substantial nexus to commerce could be demonstrated. The subject wetland appears to be chemically, physically, and biologically isolated from the TNW; the wetland was determined to be isolated consistent with SWANCC and the “Migratory Bird Rule”.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
