- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The 32-acre subject site contains a 4.2-acre lake, 7 acres of disturbed exotic uplands (forested and herbaceous), a 3-acre tree farm, and 17.8 acres of industrial development. The lake was historically used to obtain fill and is deep with no littoral shelves. The soils onsite are predominantly Arents, organic substratum-Urban land complex with a small area of Arents-Urban land complex. Both soils are somewhat poorly drained. There are no surface, sub-surface or tributaries flowing directly or indirectly that would connect the lake to a downstream TNW. The Corps does not have information documenting interstate/foreign recreational or commercial uses at the site in its current condition. The onsite waters/wetlands do not support a link to interstate or foreign commerce, and are not currently used, nor are they likely to be used, by interstate or foreign travelers for recreational or other purposes. However, current site conditions would not support the presence of fish or shellfish that could be taken and sold in interstate or foreign commerce. Based on the nature and size of the waters, it is unlikely they could support industrial purposes by industries in interstate commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
