(The JD review area does not include the Hillsboro Canal which is tidally influenced and is jurisdictional in-fact)

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 7.5-acre site has no features with wetland characteristics, and does not include any areas that were ever mapped as having hydric soils. Two upland excavated freshwater borrow ponds are present on site, and include a 0.75 acre pond and a 0.15 acre pond. Freshwater hydrophytic vegetation is present within the lake. The onsite waters do not appear to support a link to interstate or foreign commerce, and are not currently used, nor are they likely to be used, by interstate or foreign travelers for recreational or other purposes. Current site conditions would not support the presence of fish or shellfish that could be taken and sold in interstate or foreign commerce. Based on the nature and size of the waters, it is unlikely they could support industrial purposes by industries in interstate commerce. Onsite resources meet definition of Preamble waters.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Based on the nature and size of the waters, it is unlikely they could support industrial purposes by industries in interstate commerce.
