Summarize rationale supporting conclusion that wetland is “adjacent”: The C-18 Canal is the closest traditionally navigable water (TNW) and is located to the east of the review area. The C-18 is specifically listed by the Jacksonville regulatory district (SAJ) as a TNW. The canal, also referred to as the Loxahatchee Slough Canal or, in its western reaches, Hungryland Slough, was originally designed for stormwater management purposes. The canal is of high recreational value and provides for great Largemouth Bass fishing to the area with over 5 miles fishing waters accessible to anglers and boaters. The wetlands under review are in close proximity to the C-18 canal, located 580, 1,830, and 1,890 feet from the Ordinary High Water Line (OHWL) of the canal. The review area is located within the C-18 basin, in the eastern portion of J.W. Corbett Wildlife Management Area. No FEMA, state, or local flood zone maps exist for the area though a flood management study of the C-18 basin was conducted by the South Florida Water Mangement District (Technical Publication 88-11, August 1988). The report delineated the C-18 Basin into 21 sub-basins, the review area being located in sub-basin 1, which is described as “very flat and subject to long duration flooding”. The report did not produce a 100-year flood model for sub-basin 1 due to lack of survey information, but notes that the highest staff-gauge reading, taken at the CMP culverts which drain the sub-basin into the canal, was at 21.9 ft NAVD88 (after datum conversion) in June 23-24, 1982. The adjacent sub-basin to the east has a 100-year design storm peak flood stage of 21.2 feet NAVD88. Site elevations taken from a survey conducted in October 2013 vary from 21-23.5 feet NAVD88 in upland areas. Survey elevations were not taken in the bottom of the wetlands but it can be reasonably assumed that these wetlands lie at an elevation lower than these 100 year flood zone elevations. Wetlands in this basin provide for flood storage capacity. This function is particularly important to the basin as it is very prone to flooding as the western branch of the C-18 canal was greatly under-designed for the amount of runoff it receives (SFWMD Atlas of Eastern Palm Beach County Surface Water Management Basins, 1988). Near the intersection of State Road 710 and PGA Blvd, flooding from the canal has occurred several times. The wetlands under review are within a large mosaic of wetlands connected by wet prairie and shallow sub-surface flow is assumed to be exchanged among wetlands within this system. The area is largely connected by soils designated by the National Resource Conservation Service (NRCS) as hydric. A tributary to the north of the review area receives flow from wetlands within the basin, which drains into the C-18 canal.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
