Summarize overall biological, chemical and physical functions being performed: storage of flood waters, reduction of downstream peak discharge and volume, recharge of aquifers, sediment and nutrient removal, provide wildlife habitat, support diverse community of benthic invertebrates, food source for vertebrates. Additionally, these wetlands flow into Cocohatchee River which provides habitat and breeding for aquatic flora and fauna including the endangered smalltooth sawfish (Pristis) and West Indian Manatee (Ttichechus manatus). These wetlands assist in the removal of nutrients prior to reaching the estuary, reducing water degradation due to the possibilities of eutrophication, algal blooms, and hypoxia.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:




Wetland Impact Map - Keysheet


Wetland Impact Map - Sheet 1






Wetland Impact Map - Sheet 2






Wetland Impact Map - Sheet 3
