Explain: W-B, W-C, W-D and W-E are ponds and ditches which were excavated in dry land decades ago for cattle/stock watering and agriculture operations. Field investigations confirmed that these excavated features do not serve to connect the on-site wetlands to other waters of the U.S. These features are considered non-jurisdictional based on the preamble to 33 CFR Part 328 in the November 13, 1986, Federal Register (51 FR 41217, Section 328.3).

Summarize rationale supporting determination: The Tampa Bypass Canal is a 14 mile long flood control canal which originates in the Hillsborough River floodplain and terminates in McKay Bay. The canal is approximately 450 feet wide and supports parks and recreation areas along its banks. The canal is a popular fishing, kayaking and canoeing destination. Small motorboats are permitted in the canal. The canal also hosts the annual Tampa Regatta Mayor's Cup, which attracts rowing teams from around the state of Florida and the southeastern United States. Revenue from fishing licenses, bait purchases, recreational tourism and regatta entry fees contribute to interstate commerce.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": Wetlands W-A, W-F and W-G (one contiguous wetland system) are adjacent to the Tampa Bypass canal, which is approximately 630 feet west of the western property boundary of the subject site. The wetlands continue off-site to the west and have a direct hydrologic connection with the canal via culverts. North of the culverts, the wetlands are separated from the canal by a man-made berm.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


