- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: One physically isolated wetland, approximately 0.299 acre in size, is located within the southern portion of the property. This wetland has been significantly altered by silviculture and is currently classified as wet pine plantation. This wetland is best characterized as a depression system (potentially formed by the alteration of elevations during silviculture operations) and it has no direct hydrologic connection to nearby jurisdictional wetlands or downstream waters. This small system has no nexus to the adjacent wetland system or downstream waters; and, is not utilized by migratory birds and has no chemical, physical, or biological connection to downstream waters. Based on the location of this wetland and the uplands separating it from jurisdictional waters, this system is non-jurisdictional based on the *Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers, 531 U.S. 159 (2001)* (SWANCC) ruling.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical, and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
