This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Physical: Streams and their associated riparian buffers and flood plains convey water and sediment, temporarily store excess flood water, and recharge groundwater. The buffers, in particular, improve water quality, stabilize stream channels by providing erosion control, and regulate water temperature through shading.  
  
Chemical: Streams filter and entrap sediment and pollutants in overbank areas, recharge and discharge ground water, and naturally purify instream flows. Stream buffers serve as nutrient sinks for the surrounding watershed.  
  
Biological: Streams provide supportive habitat for diverse plant and animal species as well as a wildlife corridor for wildlife movement. Stream buffers provide organic matter (e.g., leaves and large woody debris) that is critical for aquatic organisms. Productivity in downstream waters can depend on the exchange of nutrients within the floodplains.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A desk review was completed using current and historical aerial imagery, the National Hydrography Dataset flow lines, and other remotely sensed data available on the districts Resources at Risk database to determine presence and proximity of wetlands and surface waters. St. Joes Creek is a perennial canal that flows to the Gulf of Mexico via Cross Bayou.

Significant Nexus Determination: Florida is in the Eleventh Circuit and the Eleventh Circuit has concluded that the Kennedy standard is the sole method of determining CWA jurisdiction in that Circuit. Therefore, unless the aquatic resources are traditional navigable waters or wetlands adjacent to traditional navigable waters, the Corps needs to conduct a significant nexus determination on all other waters in order to determine jurisdiction under the CWA. *United States v. McWane, Inc., et al.*, 505 F.3d 1208 (11th Cir. 2007). The Corps has determined that for this review, St. Joes Creek has more than an insubstantial or speculative effect on the physical, chemical, and biological integrity of the downstream TNWs, as described in Section III(C) of this form.
